#### **(b) Cancellation Policy.**

The below mentioned procedures will be followed, in case of cancellation after payments made for hiring charges.

- i. If the cancellation is made before the car leaves our office, refund will be made fully after deducting the transaction fee.
- ii. If the cancellation comes in after the car leaves our office, the lowest slab will be charged.

#### **(c) Payment:**

You have to make full payment of all amounts due and payable by you for availing of a car by Credit Card or as per Select Cabs Credit Policy at the time of booking.

The payer (credit card holder) for the booking must be the renter / main driver and must present a credit card in the same name at pick up time.

Payment can be made by: Master, Visa and American Express. As certain credit card companies may not be represented in all countries, it is advisable to verify in advance the acceptance of a given card.

Credit cards are accepted to the limits authorized by the credit card company.

(d) Refund

- i. Charges made will be refunded if found wrongly charged and/or charged twice or more.
